Further, by sharing your details with us, you also agree to receive e-mails including newsletter, campaign updates, advertisements, inter-alia with regard to our services.

What is covered in this Policy?

This Policy covers how bricons treats personal information that bricons collects, receives, uses, stores, shares and protects including information related to your past use of the Website/App products and services.

When you register for our service, we would require your personal information that is

personally identifiable like your name, address, email address, or phone number, and other information that is not otherwise publicly available and is essentially required for registering and receiving services from us.

Privacy – Our Rules

We guarantee that we will not rent and sell your personal information to third parties (except as stated in this Policy) without your consent. What Information is collected from you.

Personal Information

Bricons collects the details provided by you on registration (email address, name, password, phone number, address and some profile details and interests) together with information we learn about you from your use of our service and your visits to our Site/App. We also collect information about the transactions you undertake including details of payments and type of cards used. We will not collect and store information related to your credit cards such as number, expiry date and CVV number.

Use of Information

We use your personal information to allow it to process your registration, to process any orders that you may make for any products or services displayed on the Website/App, provide you with improved services, contact you when it is needed by telephone, facsimile and e-mail, and to advise you of products and services which may be of interest to you, inviting you to be a participant or a respondent to an online event that is hosted by bricons. Further, the relevant information is used by bricons to (i) provide you with updates of your account; (ii) to communicate with you on any matter relating to the conduct of your account; and (iii) to communicate the details of any orders / processing of any orders placed by you relating to products displayed on the Website.

Information Security

We take appropriate security measures to protect against unauthorized access to or unauthorized alteration, disclosure or destruction of data. These include internal reviews of our data collection, storage and processing practices and security measures, as well as physical security measures to guard against unauthorized access to systems where we store personal data.
